While dealing with one of the cases which was structurally designed by a consultant and duly approved by Chief Engineer, it was observed that covers for reinforcement provided in the drawing was from the main reinforcement instead of main reinforcement including distribution reinforcement, links and stirrups.

In this regard, reference is invited to Clause 26.4 of IS:456-2000 and CE(Design) Circular No.20(Revised-2003) issued vide CE(D)TC/13/04/DDA/379 dt. 18.9.03 which specifies the nominal cover to all steel reinforcement including secondary reinforcement, distribution and stirrups unless shown in the drawings otherwise.

It is enjoined upon all concerned once again that while approving the structural drawings the provisions made in Clause 26.4 of 1S 456-2000 and Chief Engineer(Design)'s Circular No.20(Revised-2003) shall be strictly adhered to.

CIRCULAR NO. 159

SUB: Processing of inspection reports for the inspections conducted by O.C. Cell

In partial modification of previous instructions the following procedure would be adopted for approval and issue of the inspection reports and their subsequent processing/disposal.

Monthly programme for inspection of works shall be drawn by EE(QC)/SE(QC) well in advance and got approved from CE(QC). While drawing the programme the instruction issued from time to time may be kept in view. The inspection reports for the works inspected by Q.C. Cell shall be digited in two categories, namely Category 'A' & Category 'B'.

CATEGORY-'A': Inspection Reports for works inspected by EE(QC) shall be approved by SE(QC) and need not be put up to CE(QC) for approval. However, a copy of such reports be endorsed to CE(QC) for his perusal.

CATEGORY 'B': Inspection reports for the works inspected by SE(QC) shall be put up to CE(QC) by SE(QC) for his approval. The inspection reports for works inspected by CE(QC) shall be directly put up to CE(QC) by EE(QC) and need not be routed through SE(QC) for approval.

Though in the first instance the reports will be addressed to EEs concerned for reply, the observations on overpayments, serious shortcomings in NIT/agreement and matter attracting vigilance action should be brought to the notice of SE/CE for their immediate attention and comments.

The teply to Inspection Reports or the rejoinders issued by Quality Control shall be examined and disposed off by SE(QC) at his level for the Category 'A'. However, for the Inspection Reports of category 'B' the replies will be put up to CU(QC) through SE(QC). Any para referred to SF or CF concerned shall be dropped with the ar proval of CE(QC) only even for Inspection Reports of Category 'A'. Normally no proposal for acceptance of sub-standard work shall be accepted without the approval of CE(QC). The matter of procedural lapses shall be dealt at level of SE(QC) and need not be put up to CE(QC). However, the concerned EE(QC) shall maintain the record of procedural lapses/non-compliance of departmental instruction Division-wise and put up the quarterly compiled report for perusal of CE(QC) and for taking appropriate action.

The FEs(QC) during their subsequent inspection shall invariably verify the compliance of important/serious observations as made in the previous inspections and noncompliance thereof shall be brought to the notice of concerned SE(QC)/CE(QC), who shall take suitable remedial measures promptly.

Divisionwise Annual Reports shall be compiled at the end of the year indicating financial & procedural irregularities and shall be provided to the concerned C.Es. for taking appropriate Administrative/Contractual action and evaluation of performance report of the concerned officials/contractors.

The HOPE water tanks provided in the buildings should not only be of Food Grade (prairy, but also be ISI marked. Instances have came to the notice of this office that special conditions/ appealed with the Aget. in regard to HIPE water storage tanks neither specify for the I.S.I. marking nor the guarantee period nor the testing requirements. The tanks should necessarily be FBA (Food Drug Administration) approved and quality is to be got tested from reported agencies like CBIU. Norkee of NESHI and the guarantee cover provided by the manufacturer is to be endorsed to D.D.A. Suitable conditions in this regard need to be invariably codered in the Aget.

It is, therefore, enjoined upon the NIT approving Authorities to enduce that conditions incorporated the complete & specific and should be followed seticulously by field staff before any payment is made.
