Vigilance Organizational set up

The Vigilance Organization in DDA is headed by Chief Vigilance Officer who is assisted by Director/Dy. Directors/Asstt. Directors for vigilance matters of non-technical nature and Superintending Engineers/Executive Engineers /Assistant Engineers for matters of technical/Engineering nature.

The Chief Vigilance Officer is primarily responsible for enforcement of anti corruption measures in the DDA and for implementation of instructions/ guidelines issued by the Central Vigilance Commission, New Delhi for maintenance of integrity in public services.

As per Vigilance Manual (Vol. I) of CVC, any information about corruption, malpractice or misconduct on the part of public servants, from whatever source, would be termed as complaint. Accordingly, the petitions/complaints/source reports sent by the Central Vigilance Commission/CBI/Directorate of Vigilance, Govt. of NCT of Delhi and public complaints are examined with due care at the level of senior officers. Depending upon the outcome of investigation/enquiry, if a prima facie case is made out, disciplinary or legal proceedings are initiated against the delinquent govt. servants with approval of Competent Authority/ advice of the Central Vigilance Commission, as the case may be.

Generally the complaints received from the public are of the following nature.

1. Signed complaints - are attended to and action is taken up.

2. Anonymous complaints - are discarded

3. Pseudonymous complaints - eventually get discarded

As per the CVC instructions, no action is to be taken by the administrative authorities, as a general rule, on anonymous/pseudonymous complaints received by them. In case of doubt pseudonymous complaints may be verified from the complainant and if he cannot be contacted at the address given in the

complaint or if no reply received within reasonable period, the complaint may be presumed to be pseudonymous and should accordingly be ignored.

If the complaint is of verifiable nature then investigation is done on the basis of contents otherwise a decision is generally taken to give a hearing to the complainant. So the Public/complainants are advised to mention their complete address alongwith their name and telephone/mobile number so that they may be contacted, if so required.

PREVENTIVE VIGILANCE TAKEN

- 1. Procedures, rules, regulations are being put up on the web-site with special focus on increasing transparency.
- 2. To reduce the interference of touts in day to day working of various branches, the entry/exit points of Vikas Sadan have been reduced.
- 3. A number of inspections have been conducted to check the menace of the corruption in various branches.
- 4. Process of e-Tendering has been revised to check pooling of tenders.
