

CIRCULAR NO. 650

**SUB.: Non-stipulation of Departmental materials such as Cement and Steel and additional conditions to be incorporated in contracts for future works in DDA.**

1. Difficulty in the departmental procurement of cement and steel was considered in the 14<sup>th</sup> meeting of the Works Advisory Board of 2010 held on 3.6.10 as per agenda item submitted by the Dir. (MM).
2. In super session of instructions earlier issued vide this Circular No. 566 dt, 9.9.04 whereby Deptt issue of Cement and Steel was stipulated only for works up to the cost of Rs. One Crore, it has now been decided by WAB that henceforth there shall be no stipulation of departmental materials such as cement and steel (free of cost or otherwise) in future DDA works irrespective of cost. In all future NITs conditions regarding procurement of cement and steel by the agency shall be introduced by the NIT Approving Authority. It will be ensured by the Field staff that materials to be procured by the agency shall confirm to the specifications as laid down in the tender documents/ BIS standards.

Sub : Delegation of Financial Powers for execution of balance works, on work order basis – C/o 1904 Mega Houses behind D-6, Vasant Kunj.


In order to achieve timely completion of the work of C/o 1904 Mega Houses behind D-6, Vasant Kunj, powers delegated to CE(D-6, Vasant Kunj Housing) in respect of award of work without call of tenders vide Item No. (i) of Sl. No. 3 of Delegation of Financial Powers to the officers of Engineering Wing issued vide OM No. F.5(287)2005-06/PC/DDA/Pt./204 dated 21/11/07 to undertake work without call of tenders ( on work order basis) is hereby enhanced from the present limit of Rs.10 lacs to Rs.25 lacs under his own authority. These powers shall be exercised by the CE, D-6, Vasant Kunj Housing without any annual limit in respect of above mentioned work.

The power for splitting up the works/items for the purposes of award of work on, Work Order basis, is also delegated to the CE, D-6, Vasant Kunj Housing.

These powers are enhanced in accordance with the recommendations of the WAB as authorized by the authority vide its Item No. 139 dated 29/12/1976.

These powers shall be exercised for the above mentioned project only and will not be quoted as precedence for any other work.



**Sub: Water testing for DDA Projects such as Housing works, RCC works like fly-overs, covering of drains, roads etc. and other works of similar nature including specialized works.**

All the Technical Sanctioning Authorities are asked to conduct appropriate number of water test(s) from the project site to assess the quality of water as per relevant clauses of IS: 456-2000 fit for construction purposes. The result of the test(s) so obtained may be made a part of NIT so that the agency is aware of the quality of water available at project site. The agency while quoting the rate will add the cost for making the water fit for construction by defining the arrangement/machinery it is likely to use to make water fit as per IS: 456-2000 in the tender document itself.


The above condition will apply to all works mentioned in the subject above and form part of the tendered document. The site Executive Engineers shall ensure the implementation.
