- 1. The following documents are required to be submitted:
 - For the Loss of Registration Certificate: Affidavit
 - For the Loss of F.D.R.: Indemnity Bond Affidavit
 - For the Loss of Registration Record: Indemnity Bond
 - Affidavit should be executed on Rs. 10/- non-Judicial stamp paper duly attested by the Notary Public or 1st Class Magistrate.
 - Indemnity Bond should be executed on Rs. 100/- non-Judicial stamp paper duly registered with the Sub-Registrar.
