For S.No 2 : The tenders will be sold in the office of the EE, WD-15 after verification the following :

- I) The satisfactroy completion of at least two works of similar nature/class,each costing not less than 50% of the estimated cost (gross) of the proposed work in Central/State Govt./PSU/Govt. Autonomous bodies during the last five years.
- II) The annual financial turnover in soil investigation work in the one of the preceding 3 financial years shall not be less 100% of the estimated (gross) value of the works (duly audited by Charted Accountant) on annulized basis (depending upon the time allowed for completion i.e. total estimated value divided by time of completion.)

For S.No 9 & 10 : Contractor/firms who fulfill the following requirements shall be eligible to apply. (joint ventures not accepted.)

- a) should have satisfactorily completed three works of multi-storeyed building with or without basement (at least one of them in Central Government / Central Autonomous body/Central PSU) each costing 40% of estimated cost put to tender or two works each costing 50% of the estliamted cost put to tender or one work costing 80% of the estimated cost put to tender during the last seven years ending last day of the year i.e. 31st March 2007.
- b) Should have had average annual financial turn over on construction work of at least 30% of the estimated cost put to tender during the last three years ending 31st March, 2007.
- c) Should not have incurred any loss in more than two years during the last five year ending 31st March, 2007.
- d) Should have a bank solvency not less than 40% of the estimated cost.
- e) The cost of respective works completed by an agency shall be suitable enhanced @5% for each subsequent year following the financial year in which that particular work had been completed to bring at par with the present cost. Enhancement on the similar lines shall also be effected in respect of turnover of the agencies.
- f) Should have a valid certificate of registration with Work Contract Cell, Sale Tax Deptt. / VAT Deptt. of GNCTD & the tax clearance certificate in form XI.
