Third Meeting of Management Action Group (MAG) on “**Environment Planning and Co-ordination**” was held on 19<sup>th</sup> March’ 2012 under the Chairmanship of Secretary (Environment), Govt. of NCT of Delhi, in the Conference Room, Deptt. of Environment, 6<sup>th</sup> Floor, C-Wing, Delhi Secretariat, I.P.Estate, New Delhi. Secretary (environment), GNCTD welcomed members, expert members, and special invitees to the third meeting of the group. Thereafter, agenda items were taken up for discussion.

**2 Confirmation of minutes of 2<sup>nd</sup> meeting of MAG held on 02.03.2012.**

In absence of any suggestions / comments on the minutes of the review meeting of the MAG circulated vide No. F.1(16)/2011/Dir(Plg)/MPR&TC/95 dated 14.3.2012 the minutes were read as confirmed.

**3. Action taken note of 2<sup>nd</sup> meeting of MAG held on 02.03.2012.**

- i) The status of boundaries of Ridge Reserve Forest/Regional park & other forest land was explained by the officials of the Department of Forest ,GNCTD. The table top exercise has been started taking into account seven notifications.
- ii) Director (Plg.) Zone'O', DDA marked location of the unauthorized Colonies on the copy of the Zonal Development Plan of Zone 'O', as per the list provided by Urban Development Deptt. of GNCTD. It was further informed by Director(Plg.) that the detail boundaries of unauthorized colonies are being finalized/fixed & transferred on geo-referenced revenue Map with the help of DSSDI.

4. i) Chairman informed the Group that the Chapter of 'Environment' in the Master Plan is being revisited afresh and the same would be discussed in next meeting of MAG.
- ii) The Addl. Commissioner (Landscape), DDA, pointed out that part of the regional park has been notified as Reserve Forest under the Indian Forest Act, 1927 vide notification dated 24.5.94 and 2.4.96. There are discrepancies between the area notified and the physical boundary of the total area own by various agencies – DDA, CPWD, NDMC, MCD, Forest Deptt and the Ministry of Defence.
- The Conservator of Forest in response to the observations made by Addl Commissioner (Landscape) informed that a Special Task Force had already been constituted vide order no. F.8(328)/Forestland/Planning/2011-12/1204-25 dated 16.2.2012 read with No. F.8(118)/PA/CF/RUC/Pt.IV/7709-23 dated 28.2.2012 for the purpose of identification and demarcation of notified forest land (Wildlife Sanctuary, Reserve Forest, Protected Forest), land allotted to the Forest Deptt by various authorities for the purpose of plantation and creation of Reserve Forest (1996 Notification), morphological ridge as also the extent of land under non forestry use within the confines of above categories of lands in South and South West Revenue Distt, based on relevant records, notification and administrative orders in a time bound manner.
- iii) As regards the issue of regularization of unauthorized colonies in Zone 'O' was concerned, it was informed that the notification issued for regularization of unauthorized colonies in NCT of Delhi does not prohibit regularization of such colonies in Zone 'O' subject the fulfillment of the eligibility criteria laid down for the purpose. However, the members present in the meeting were of the view that the land used in Zone 'O' requires to be revisited keeping in view the development taken place in the area.

**5. Other Item:**

- i) Director (Environment) GNCTD informed that the mandatory provision made for the office orders issued by the DDA regarding adoption of measures towards conservation of water in building plans have been sent to all concerned for necessary action by the concerned Department while sanctioning the building plans/ various projects.
- ii) Secretary (Environment) informed that the Deptt of Environment shall make a presentation before the Advisory Group meeting to be held on 21.03.12.

The meeting ended with vote of thanks to the chair.
