

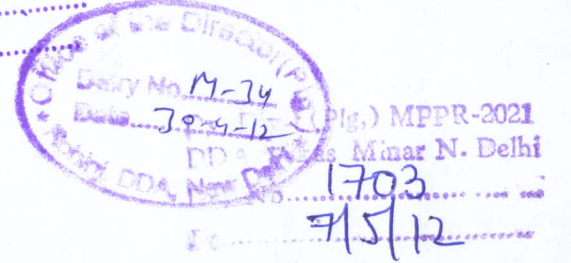

विषय:- शहरी विकास मंत्रालय, भारत सरकार द्वारा समाचार पत्रों में दिनांक 18.02.2012 को मास्टर प्लान दिल्ली 2021 की समीक्षा- एक सहभागिता प्रयास विज्ञापन प्रकाशित किया । इस संबंध में कृष्ण कालोनी प्रहलाद विहार रोहिणी में बसी हुई कालोनी के संबंध में ।

महोदय,

निवेदन यह है, कि हमारी कालोनी 1993 से बसी हुई है, जो कि दिल्ली सरकार द्वारा नियमित किये जाने वाली कालोनियों की लिस्ट में है । जिसका रजिस्ट्रेशन नं० 888 है । शहरी विकास मंत्रालय, दिल्ली सरकार द्वारा जारी रिवाईज दिशा निर्देश के तहत सारी शर्तों को पूरा करती है । जिसके तहत कालोनी को प्रोविजनल सर्टिफिकेट जारी किया गया था ।

दिल्ली सरकार के शहरी विकास विभाग ने 27.10.1999 को रोहिणी रेजिडन्सियल स्कीम हेतु कालोनी की जमीन का अधिग्रहण कर लिया था, वेलफेयर एसोसिएशन ने कालोनी को बचाने हेतु माननीय सुप्रीम कोर्ट में SLP-13431/2007 लगाई थी, जिसका निर्णय (Judgment) दिनांक 21 मार्च, 2012 को आ गया है । (Judgment की फोटो कापी संलग्न है)

दिल्ली विकास प्राधिकरण के द्वारा जो जोनल प्लान बनाये गये हैं, उस नक्शे में कहीं पर भी कालोनी का नाम नहीं है, जबकि जोनल प्लान बनाते समय आर डब्ल्यू ने अपनी आपत्ति दिल्ली विकास प्राधिकरण के पास जमा किया गया था । (आपत्ति दर्ज की फोटो कापी संलग्न है)

अतः आपसे अनुरोध है, कि मास्टर प्लान 2021 के सुझाव में हमारी कालोनी को यथावत बनाये रखने एवं कालोनी का नाम जोनल प्लान के नक्शा में दर्ज करवाने हेतु उचित कार्रवाही करने की कृपा करें ।

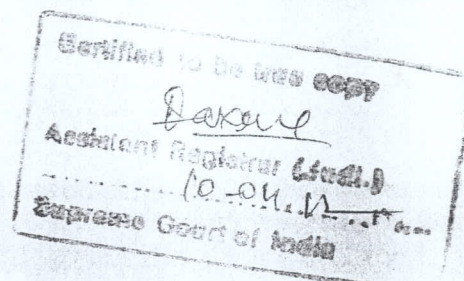

Leave granted.


2. For the reasons given by us in our judgment delivered today (March 21, 2012) in Civil Appeal No. 3813 of 2007 - Ram Dhari Jindal Memorial Trust vs. Union of India and others which arises from the very judgment which is impugned in the present appeal, this appeal is allowed to the extent immediately following.

3. The clause in the Notification dated October 27, 1999 to the effect "the Lt. Governor, Delhi is satisfied also that provisions of sub-section (1) of Section 17 of the said Act are applicable to this land and is further pleased under sub-section (4) of the said Section to direct that all the provisions of Section 5A shall not apply" is

quashed in respect of the appellant's land. The declaration dated April 3, 2000 issued and published under Section 6 of the Land Acquisition Act (for short "the Act") concerning the subject property is also quashed. The Competent Authority may now invite objections under Section 5A of the Act pursuant to the Notification dated October 27, 1999 and proceed with the matter in accordance with law. No order as to costs.

4. In view of the above, I.A. No. 2 of 2007 for direction and I.A. Nos. 3-4 of 2010 for re-calling the order dated October 9, 2009 do not survive and stand disposed of accordingly.

The unauthorised colonies fulfilling those conditions shall only be considered for final regularization.

The final boundary of the aforesaid colony would be fixed by the GNCTD only after completing all requisite formalities including those in Clause 3 of the Regulations.
