Sir,

At the outset we would like to congratulate you under whose supervision DDA has come out with a notice inviting public suggestions for mid-term review of the Master Plan for Delhi 2021.

When the Master Plan 2021 was drawn up, there appears to have been an oversight in so far as the two roads **RAJESHWAR ARYA MARG and HARGYAN SINGH ARYA MARG in NDSE PART-1.** The MCD did not take cognizance that they were in fact Pre-1962 colonies and came to be categorized under A to G being Mixed Land Area.

Further, it is requested that you may please have this examined and if need be it is humbly requested that you may personally intervene to have this error examined so that the oversight is corrected and instructions given to make the necessary amendments for the Mixed Land use of the two roads i.e. **RAJESHWAR ARYA MARG and HARGYAN SINGH ARYA MARG in NDSE PART-1.**

We once again request you to consider our case on merit and bonafide usages and declare both these roads in the Mixed Land category as per our request in Para 'a' mentioned in the subject.
