Subject: Suggestions for review of Master Plan of Delhi relating to Zone P-I and P-II

Sir,

Kindly refer to your advertisement in the Times of India published in the month of April, 2012 on the subject cited above.

In this connection, I am to submit the following suggestions for your kind consideration:-

1. In its letter no K-12011/23/2009-DDIB dated 8th March, 2010, the Ministry of Urban Development, laid down six stipulations/conditions to be fulfilled in respect of the Institutions which have been regularized in principle by the MUD. Our school is one such institution. In its letter to the school, the DDA has quoted these six conditions verbatim and put the onus of getting the clearances from the concerned Government departments on the schools concerned.

This is an impracticable step which is delaying the final regularisation. It is not easy for a private organization to obtain information/clearance

from the Government. It is suggested that the DDA obtains the clearances at its own level from the agencies concerned.

2. In some zones, all the six clearances have been mentioned as in ours but in some districts e.g. Dwarka, only the stipulations relating to the forest department, the ASI, and the ownership of the land have been mentioned. This has made the task of regularisation very easy. It is suggested that in place of asking for all the clearances mentioned by the MUD, the DDA should insist on essential conditions which the schools can fulfill but for conditions at serial no (a), (b), (d) and (f), it should take initiative at its own level because this information is already available with the DDA.
