The following suggestions be included in Master plan in 2021

1. The provisional regularization of unauthorized colonies certificate of Khera Kalan & Khera Garhi extended abadi provided by Hon'ble Chair Person Mrs. Sonia Gandhi of UPA Govt. of India on 04-10-2008 having Reg No: 76ELD dated 17-9-2008. It is requested you to be declared as lal dora and provision of mixed land use be allowed.

2. The extended abadi beyond lal dora of village Khera Kalan & Khera Garhi within radius of 10 acres from the Phirani/ Lal dora declared as a part of Lal dora and enmities be provided

and status of mix land use be allowed.

3.The build up area residential and commercial be declared as regularized as a part of Lal dora. These unauthorized constructions / colonies have grown organically along with rural road and beyond the Lal dora of Khera Kalan & Khera Garhi Delhi-110082.

4. The farm houses , schools , playgrounds , recreational activities , communities halls and marriage party homes are existing in the area of village Khera Kalan , Delhi.
