Sub: - Suggestions for review of Master Plan Delhi - 2021

Ref : - DDA's notice appeared in the newspaper regarding open house meet- Central District,
on 15.05.2012

Dear Sir,

In reference to the above, Sant Vihar Welfare Society (RWA) is submitting the following suggestions for your kind consideration :-

1. Third floor construction may be allowed for houses situated in New Daryaganj area, including Ansari Road alongwith its by-lanes. The existing floor area ratio (FAR) may kindly be increased. The already constructed all floors may please be regularised.
2. Parking of cars, scooters & motorcycles is a major problem in New Daryaganj area. As such, suitable parking spaces may be developed in this area. A few spaces identified in this regard are :-
 - (a) Below Mahavir Vatika a basement and ground floor parking area can be developed and above that a multi utility, complex comprising of a Comunity Centre, Library, Coffee Shop, a medical shop and Public Gym etc.
 - (b) The open space / park situated on the stretch from Ghata Masjid Road towards Ring Road can be developed as a parking area with the provision of Park and Ride facility.
 - (c) The open stretch near the entry point of Ansari Road from Delhi Gate side and behind Babu Jagjivan Ram ji's Samadhi Sthal, **which is presently being used only as a dumping ground of garbage / malba etc.** can easily be converted as big multistoryied parking space after cleaning up the said area.

It is further suggested that if it can not be development as a parking area, at least it can be cleaned up with tree plantation for developing green area alongwith some water fountains - so that the entrance of Ansari Road can be beautified and the dirty look at the very entrance is finished

In the end Sir, we hope the above proposals will meet your approval and help in making Delhi "Clean & Green".
