Dear Sir,

We welcome the move by DDA to invite suggestions on MPD 2021. We have following suggestions given below.

1. The population of Delhi has increased many times in last 10 years. Presently the population of Delhi to the about 1.75 crores, which will grow 5 crores in next 10 years. If present rate of growth is there.

The main reason is the growing industrialization. The stress is on employment as well as the service sector and ancillary units along with transportation required for these units.

**We purpose that the land use of Industrial Area be converted into Residential Area irrespective Size of the Plot.**

This will help the Industry to move out in NCR without any hue and cry. We are in a democratic setup. This will be the best suited option for decongesting Delhi, similar step are being taken by Gaziabad Development Authority more over China is a role model in this step. Shangai is a living modern of the city with adjoin industry. We humble suggest the change of land use in all Industrial Area of Delhi be promoted to Residential.

2. The F.A.R. in Industrial Areas should be increased uniformly in all Industrial Areas in respective of the size of the Plot to 25%.

3. The redevelopment of Industrial Areas having 70% Industries were Purposed in 2005, but the implementation is pending with MCD & DDA, no work has started till date. We request you to please setup time frame completion of development of these Areas. Sawaran Park Mundka has completed there Planning & handed over the Scheme for development to DSIIC for redevelopment. We request to DDA to make Delhi a WORLD CLASS City.
