Subject : Suggestions for Improving the Infrastructure in Delhi / Naraina Vihar

Dear Sir,

Thank you very much for inviting us to present our views on improving the infrastructure of Delhi in review of MPD 2021 on 5th November 2012.

During our presentation a copy of our letter dated 14th May 2012 and your letter dated 17th August 2012 were personally handed over to you by the undersigned.

We wish to highlight the important aspects addressed by us to improve the infrastructure in Naraina Vihar and Delhi :-

- Under Pass at the PVR and Ring Road T – Junctions** to make it signal free for smooth traffic flow. Also, at PVR Junction to enable pedestrians cross the busy Girdhari Lal Goswami Road. At present, the Road Crossing is a prolonged wait and dangerous.
- Banks** to be allowed only in the respective Community Centres of each block and not in the residential areas to prevent traffic jams and uninterrupted traffic flow. Unevenly parked Vehicles around these banks create chaos and road blocks. Community Centres to have adequate parking facilities for Banking Staff, Customers, other Shops / Offices etc., either on the surface or underground.
- Hotels / Guest Houses** : have come up on the residential side of the Girdhari Lal Goswami Road between Ring Road T – Junction and PVR due to Mixed Land Use allowed on this stretch. Cars parked in front of these Hotels / Guest Houses which ideally must be parked inside the Hotels cause traffic jams. Water requirement and Sewage discharge has increased due to them. Such a burden on infrastructure in the colony must be compensated by augmenting Water Supply and Sewage System.
- Bus Stop** : on the Ring Road is very close to the T – Junction. Buses coming from Mayapuri block the traffic on the Ring Road. It must be shifted to the earlier position, i.e. facing " A " Block shopping Complex, near Kali Mandir to allow free flow of traffic. Some accidents have also taken place.

Another bus stop on Girdhari Lal Goswami Road, near Ring Road T – Junction, also creates traffic congestion when buses are coming from PVR Side. The existing Bus stops are hazards to Road Safety.

- Hawkers** : at their will locate themselves inside the colony to sell their products. Vehicles stop and restrict the internal roads causing traffic jams. Number of hawkers increase periodically, remain unchecked and uncontrolled causing unhealthy conditions with constriction of internal roads. Limited Hawkers must be allocated a place in consultation with respective RWAs and with Issued Licences.

6. **Water Supply** : Nāraina Vihar's Population has increased with time. Some Houses have gone / are going vertical. This has put a strain on both the sewage and water requirement. Water Supply must be augmented to meet the present increased requirements. Sewage and Storm Water Drainage System be increased to meet present and future requirements.

7. **Yamuna River** which used to be a Natural Source of water for New Delhi is useless due to heavy pollution. Government must take Immediate Remedial Measures to initiate steps to prevent all Sewage, Industrial Waste discharging into Storm Water Drains, etc. entering the Yamuna River and heavily polluting it. Water flowing in this River can be used to meet the needs of cities like New Delhi.

Central Government must ensure all the Sewage, Industrial Waste being discharged into the Yamuna River along its path must be directed to localised Effluent Treatment Plants in each Area / City / District. Treated water must be recycled within the Area / City / District. All Sewages, Industrial Wastes, Storm Water Drains etc along the path of Yamuna River must be stopped so that the River does not get polluted.

Central Government has spent Rs. 4000 Crores for cleaning Yamuna River. But it is still polluted as before. Haryana is taking water from the same river very close by. Then why should we beg for water from Haryana. Our FONARWA has done segregation of Sewer from Storm Water Drains as explained in our above quoted letter dated 14th May 2012, which may be followed by other areas in Delhi.

8. **Railway Bridges** :

a) Railway Bridge between " H " Block and Inderpuri is in a dilapidated condition with steep gradient, inconvenience to old people and ladies. It needs proper renovation / reconstruction.

b) Similarly, another Railway Bridge between " C " Block and cremation ground needs to be redeveloped with proper slope gradient.

We will certainly appreciate the implementation of our above suggestions for improvement of Infrastructure of Delhi / Naraina Vihar at the earliest.
