1. Slow traffic is main cause for poor position of Transport it should be removed with Battery Rickshaw, Feeder Buses must be maintained.
2. Metro service should be preference for our area under Third Phase.
3. Metro should be connected with Tis Hazari / Kashmiri Gate to New Delhi/Connaught Place. East, North & South side as there wide scope of acquiring land over there.
4. The feeder buses should be provided to connect Connaught Place to Tis Hazari and R.K. Ashram to Pul Bangash as a number of people use this route daily.
5. Encroachment should be removed for the smooth play of traffic.
6. Qutab Road Tanga Stand has been removed which should be replaced with Prepaid Taxi and Scooter Stand so that the scene of the market could be changed.
