12.3 : ROADS: - upto para 12.3.4: All ROWs mentioned therein existing & proposed developments may be increased by 30% considering future vehicular load. It is also suggested that possibility of alternative elevated roads and flyovers may be explored on inner and outer Ring Road as well as all other main roads for easy flow of vehicular traffic.

12.5 : BUS :- It is suggested that (BRTS) may only be planned on minimum road width of 45.0M instead of 30.0M 12.7

12.13.2,12.13.3,12.13.4 & 12.13.5: - Parking:

Since Commercial activities have increased considerably in Metro as well as NCR there has been no parking space available due to which lot of commercial vehicles as well as personal vehicles are parked on roads specially in the existing colonies. The local authorities are not able to provide sufficient parking lots. It is suggested that underground parking may be allowed below the parks available in almost all the colonies existing are being developed in future & parks above parking. It is also suggested that parking above storm watery nallahs can also be considered after covering with fly Charlians can also be considered parks which has been done recently in MOR colonies in which 09.11-12 many parks are available almost in each block.
