Respected Sh. Kamal Nath, Minister of Urban Development India New Delhi.

After observing ZERO response from the authorities marked in Copy. We wish to bring this grave and hazardous matter into your kind notice.

We are a group of sane citizens and on behalf of our Society, I wish to bring this grave and yet another scam to your kind notice, with hope that immediate action would be taken to safeguard the citizens of Delhi and others. The capital city of our country is passing through the turbulent times and is in a complete mess, Everywhere illegal construction works are in full bloom.

The Delhi govt. and the civic bodies are running against the time to complete the projects like flyovers, roads, parking places, beautification etc. No doubt the projects are undertaken by the govt. will change Delhi for good and the concrete structures of underpasses, flyovers, bridges etc will result in world class city. Although, the country appears quite committed for the safeguard of world environment, but what about its own environment which is being continuously degraded and exploited for the sake of meeting our own narrow ends? On one hand, we talk of conservation of environment and on the other hand we cut trees, filling up of ponds and marshy lands which serve as perfect ecosystem for the existence of varied food chains, showing our govt. sincerely towards this global cause.

As a responsible citizen of this nation we can hardly bear that the govt, should turn blind eye towards the other concerns faced by this capital city. Not more than 10 KMs from the central Delhi the illegal construction works are running parallel in the full swing. Almost in , entire city, west Delhi especially Uttam Nagar, Dwarka Morh, Nawada and Kakrola, Patpat Gunj Ext. Pandav Nagar areas have witnessed mushroom growth of illegal colonies and unauthorized buildings. These building are built on mere 40 to 50 Sq. yard land areas because the builders in such areas understand the corrupt mentality of the civic bodies operational in such places. In the pursuit of earning quick bugs they tend to make substandard buildings, using the most inferior material and methods. So one can easily imagine how strong and secure these buildings would be for those who will reside in them (of course Aam Aadami). So much so they do not spare the lanes and footpaths around the multi storied buildings they continuously construct and then sell floor wise to a middle class buyer. These low budget apartments are welcome by middle class immigrants from Bihar. UP, west Bangal ,Lower Income Group and even Bangladesh because for them a shelter in Metropolis like Delhi is like dream come true. The kinds of material and construction methods used by these small builders to construct these multi storied floors are never strong enough to sustain against any kind of natural climate like earthquake etc. But, these unplanned colonies that have crept up have become the ultimate hell for the residents already residing, with no proper sewage and drainage facilities, no proper electric and water supply and other basic amenities' necessary for the dignified living. Every now and then neighborhoods become alive not with some constructive activity but with the quarrels and squabbles for one thing or the other. Peaceful life has become a thing of past for these residents.

The govt, being busy in beautification works hardly finds time to gear up the administrative setup of the civic bodies and other concerned organizations of these areas to look into the

gravity of this problem. The illegal construction mafia has bloomed into a full fledged nexus between small time realtors and administration. It is so deep rooted that even Police prefer to turn their eyes away rather than locking homs with them. The construction work in these areas goes on for months and years together without caring for the inconvenience that is created in the neighborhood.

If the govt, wants Delhi to be a world class city then the equitable development projects is a must. The Govt. of Delhi can hardly effort to show the discrimination by allowing the localities like Chandni Chock, Govid Puri, Uttam nagar etc. uninterruptedly to grow in numbers. If the democracy prevails everywhere in our country then the development work If at all is undertaken should not be for the few posh localities but it should be for all the nooks and corners of the state but here govt, of Delhi is showing some disparity. By not tightening the noose around the civic authorities and allowing the illegal construction to go on, it is inviting hell lot of troubles as mentioned earlier. The govt. forgets that these unattended, unauthorized colonies with poor sewerage and open drainage set ups are the breeding places for the seasonal diseases like the dreadful Dengue, majaria etc. which are taking heavy toll of lives of those living here every year and the same dengue or malaria parasite can easily reach to the posh localities or some other VIP areas nearby as unlike common man they have no obligation to pay any toll tax or cross the security barriers like police check post etc. to attack the VVIP's. Congestion is yet another nuisance in such colonies; one recent incident was experienced in Jamia Nagar locality where it was difficult even for Police vehicles to enter while nabbing the antisocial and terrorist elements. If at all this issue will be ignored and uncontrolled it would result the chaotic situation in near future. Shortage of water, electricity, pollution, heat, illegal immigration and growing crime rates are already grave concerns before the govt, of Delhi in such circumstances how does govt. afford to remain silent for such mushroom growth of illegal and unauthorized colonies. In recent days team of our NGO visited KAKROLA area (Newade Housing, Vipin Garden and nearby). We were shocked to see that the plot size 60 Sq. yacd has 2nd 3rd glin stories of 80 Sq. and more Sq. yards. There is not give sufficient air persone balween the two buildings,

After speaking to the local residents those who have been living for generations, are threatened by the mafia that they do not dare to share their grievances.

We suggest that there should be some strict and immediate norms set to overcome this grave concern like: No second story on plot size less than 50 square yards, for 100 yards not more than 2 and half stories, all those constructed in last two years against this on 50, 60 and less than 100 sq. yard must be dismantled any story above the first floor. Sufficient parking space should be left within the construction area. All those builders who have made illegal construction a full time profession should be severely punished and panelized for disturbing the serenity of the atmosphere.

For now we chose to keep our identity confidential/hidden for the security reasons and hope for your kind cooperation.
