



Thereby extending this benefit to down trodden section of our society which till date have been denied these benefits. The above fast changing scenario calls for immediate other steps which are required to be taken for proper implementation of the important

steps initiated by your Excellency.

- 3. The ill-convinced provisions in the MPD-2021 for denial of degree/diploma courses in schools are proving obstacle of stone in implementation of Policies conceived and initiated by your good self. It is further pointed out that till date DDA has not year marked any specific plot in the entire city for conducting degree/diploma classes in teachers' education. These very ill convinced provisions in MPD-2021 are resulting in the lack of these teacher training courses Degree/Diploma are part of the good school education are directly leading to exodus of potential of good quality education in these courses aspirant to the neighboring state and even to far flung areas.
- 4. Thus all could be easily avoided by modification in the already ongoing master plan review by merely adding the following provisions after which the modified MPD-2021 clause Il of chapter 13 of education would read as "coaching centres/vocational training centres/teacher training centres leading to degree/diploma would be permissible in school after school hours.."

Your Excellency is requested to endorse the modification to DDA to incorporate the above in the above ongoing review of MPD- 2021.
