2. 1 The details & plans of the following clubs were examined :

2.2 These above clubs were built in the 1980's-1190's period when FAR of Clubs was allowed @ 100.

3. It may also be advised that the area in which these above clubs were built were large &  
generally 4-5 acres each with the result that more facilities could be accommodated in the areas that  
were allowed to be built on 4-5 acres of land.

4.2 It is thus seen that the clubs built earlier were given an FAR of 100 with larger areas of land allocated to them to accommodate all required games/sports/residential facilities.

5.1 With the areas allocated to clubs becoming smaller, it is logical & necessary that the FAR should be increased to accommodate all the facilities required in a good club.

5.2 This will also ensure than no illegal or temporary construction is carried out later to accommodate all facilities.

6. We therefore urge that :

6.1 FAR Norms for Clubs be increased to 200 to accommodate all facilities:

It is only a substantial increase in FAR will allow more sports/games/residential facilities to be incorporated and the area usage can be used more efficiently.

6.2 Residential Component in Clubs

The Residential Component in Clubs should be to allowed for more members to stay & use the facilities.

This will help the clubs to have guest speakers from outside town & conferences to help enrich the life of the members.

7. Recently Norms for Hospitals, Motels & Hotels have also been increased to incorporate more facilities. The FAR for clubs may also be increased on similar basis.

8. The New Norms for Clubs should be broadly as below :-

Maximum Ground Coverage	--	50%
Maximum Floor Area Ratio	--	200
Maximum Height	--	26 Mt.

Other Controls :-

(i). 50% of the total floor area shall be allowed for residential purpose, etc.

(ii) 50% of the open area beyond the permissible ground coverage area would be used as green and 50% of the open area for out-door games/sports facilities. Swimming pool would also be permissible upto a maximum covered area of 500 sqm free of ground coverage & FAR.  
(iii) Basement: Upto the envelope line, equivalent to 2 times the area of the plot to be used Exclusively for parking, maximum 25% for storage & storage – not to be counted in FAR.

9. In view of the above we would like to request you to kindly look into the matter and provide the required amended increased development control norms as requested above at the earliest.
