1. While looking at the plan of Zone 'F' concerning Mehrauli, abadi area of Village, published under the provisions of MPD-2021, I observed that a part of the area is not shown. The revenue plan i.e. plan shown in sizra prepared by revenue authorities while preparing and drawing boundaries of village abadi in settlement of 1880-81, 1908-09, 1980-81 are different than the plan of Zone F shown in MPD-2021.
2. That sizra plan prepared by revenue authorities and the Zonal Plan shown in MPD-2021 are annexed for comparisons.

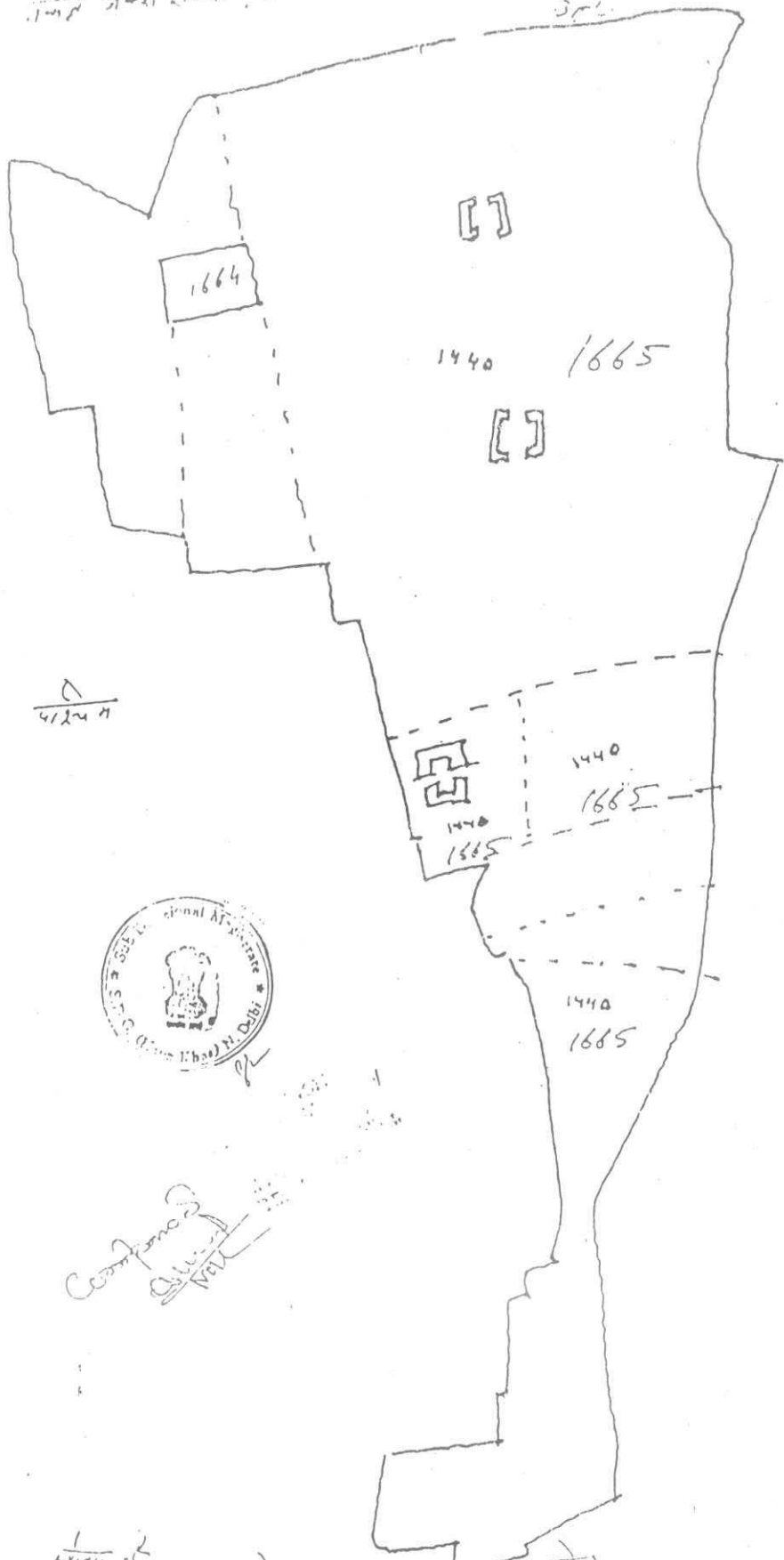

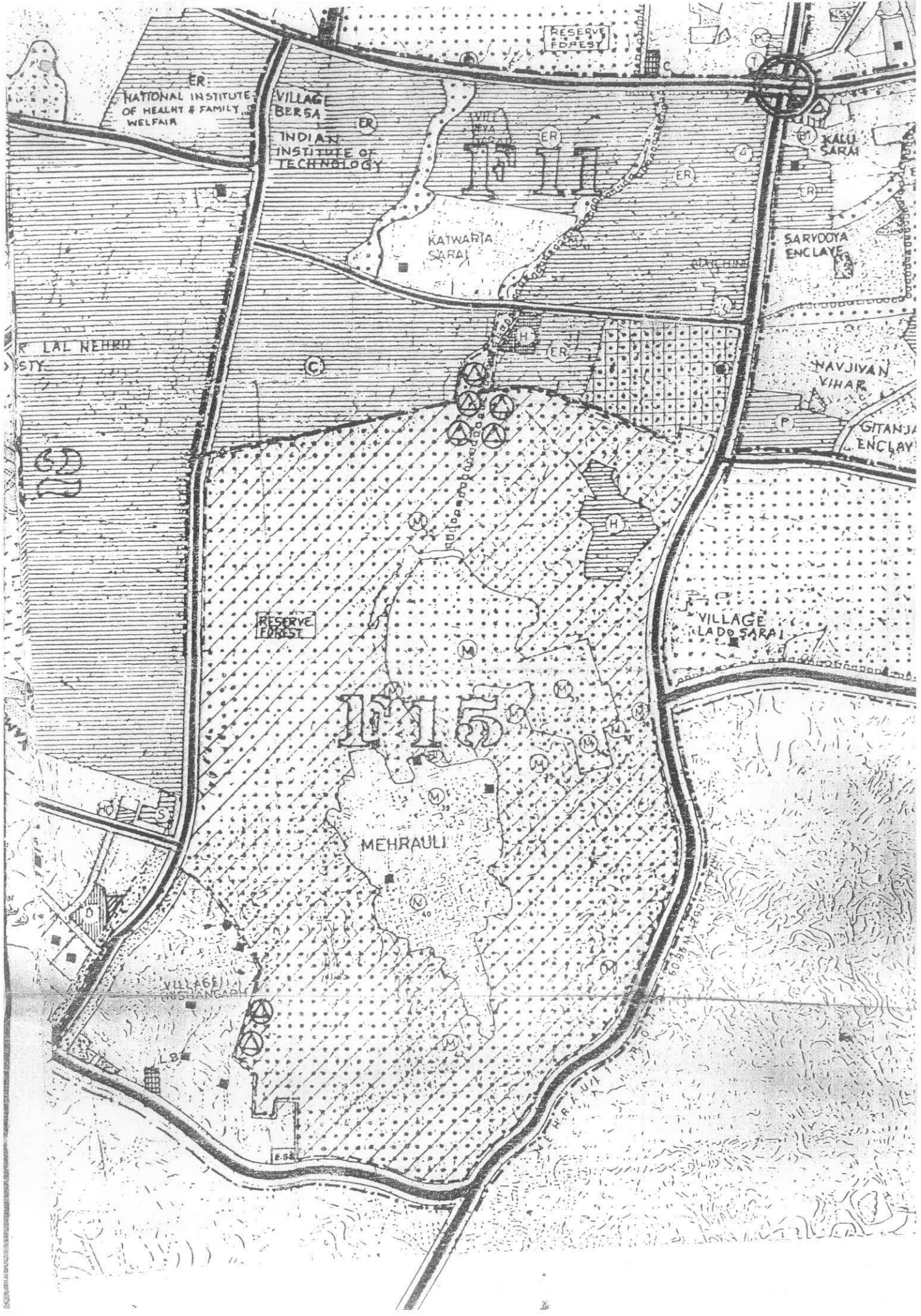
