We wish to bring to your kind attention that Shahabad Mohammadpur Village near IGI Airport should be absolutely kept under Transport Zone as per the Master Plan 2021 approved by DDA & Delhi Government because our Confederation is fighting on this issue for better development for this village. Since more than a decade our Confederation believes in development of this village at par with other villages in Delhi as international standard to give respect ample job opportunity and to promote this village at par with all developed villages of Delhi since it has a unique proximity with IGI Airport and it is unique proximity with present Railway Station Shahabad Mohammadpur, proximity with proposed Bijwasan Railway Terminal, Bus Terminal, proximity with Sector-8 Dwarka Metro Station, Dwarka prestigious metro station Sector-21 and other upcoming facilities which will definitely bring this village as a modern village in very near future. We are very much thankful that this whole area was declared as Transport Zone in approved Delhi Master Plan 2021 where Zonal also been finalized resulting that many prestigious developer, builders have applied for sanctioning on their building plans as well as lot of new development is going to come very soon.
