Sub:- Request for renewal of license running the Restaurant/Eating Houses permitted by the administration in the year 2007 on the residential premises, located on Mixed use streets.

Respected Madam,

Delhi is having about 12000 big and small Restaurants/Eating Houses in various parts of Delhi having valid license issued by Municipal Corporation of Delhi and further permission given by licensing department of the Delhi Police for running restaurants on the mixed use of the streets. The restaurants were being run accordingly with the norms prescribed by the various authorities time to time and were smoothly running their business without any interference.

Now all of a sudden-in the first week of June 2012, the office of the Addl. Commissioner of police licensing issued the notices for closure of restaurants immediately on the plea that mixed use of the streets announced earlier has been amended. Now a terror has been created by the local Police as well as Municipal Corporation inspectors with threats that they will seal the Restaurant/Eating Houses. With this order about 2 lacs employees those are working with the restaurants/ eating houses will be unemployed, in such circumstances their families will starve.

The Restaurants/Eating Houses are permitted on the residential premises located on mixed use street as it is not included in the list of non permissible activity falling under mixed use on mixed use streets under the Para 15.6.2 of the MPD-2021. Accordingly as per the rules many traders deposited conversion charges and parking charges in huge amounts.

Madam, you may recall that in the year 2007 when Supreme Court had issued the orders for the sealing of the commercial
