Subject : Setting up of Apex Committee to ensure revision of MPD-2021 is correct and appropriate – reg. Proposal of Education Department, GNCT of Delhi.

Sir,

Kindly refer to your office letter No. K-12011/7/2011-DDIB dated 19/01/2012 whereby it has been informed that an Apex Committee under the Chairmanship of the Hon'ble Lt. Governor of Delhi has been set up to ensure that the revision of MPD-2021 is correct and appropriate.

In this context it is submitted that the implementation of the Right to Education Act makes it mandatory for the Government to provide educational facilities for all children. It may be seen that the additional enrollment in Government Schools under the Govt. of NCT of Delhi, is increasing @ more than 1 lacs per year. The annual enrollment figure for the last three years is reflected below.

Academic Year	2009-10	2010-2011	2011-2012
Enrollment (Govt. Schools)	1283581	1382364	1485479

Thus to accommodate increasing number of students, to maintain an optimal pupil teacher ratio and to meet the provisions of the Right to Education Act 2009, hundreds of new Government Schools needs to be opened. For this purpose the Department has taken up the matter number of times with the DDA for allotment of suitable land.

It is understood that DDA has a policy of allotting land for two types of school :

1. Primary School i.e. from 1st to 5th class and,
2. Sr. Secondary school i.e. 1st to 12th class.

However, there is a third category of schools from i.e. 6th to 10th (Secondary) and from 6th to 12th (Senior Secondary) which are run by Dte. of Education GNCT of Delhi,

in which the classes from 1st to 5th are not there. There are already such 553 schools (from 1st to 10th or 1st to 12th) in Delhi. Generally the students from MCD schools which are from 1st to 5th classes take admission in such schools.

It is therefore, requested that the matter may be placed before the committee to consider for making the land norms for allotment of land for schools from 6th to 10th/12th at par with Primary schools for land allotment by DDA, for Education purposes.

This issues with the approval of the Chief Secretary, Delhi.
