Dear Sir,

I am writing to report that, despite the ban order directing that status quo be maintained in the colonies, construction activity is going on undeterred in B-Block Vasant Kuni Enclave in Rangpuri Area.

New houses are being/have been constructed at behind B-554 and adjacent to B-557 and behind B-69. Houses demolished between 18-22 May 2010, after the issue had been raised by the local MLA on the floor of the Delhi Assembly, have been restored and reconstituted.

The police authorities, who should have seen to it that the ban order is not violated, are looking the other way and maintaining silence.

If the DDA is not serious about the ban order, it should not have issued it. It is also making a mockery that first it demolished the houses and is now allowing them to be restored in violation of the ban order.

I am writing to point out that the DDA is duty bound to ensure that the ban order is not violated. Therefore, I urge urgent and immediate action to enforce observance of the ban order.
