Sub:- Waiver of the condition of NOC

I may bring to your kind notice that the owner of a Flat/ Floor has to obtain no objection certificate (NOC) from the occupants/owners of the other flat/ floor before carrying out any addition, extension, alterations in his/her Flat/Floor.
