Your attention is drawn to news reports appearing in a section of the media that your office has written to the Ministry of Urban Development to amend the master plan to allow for more liquor shops to be opened in Delhi and that the ministry has forwarded this request to the D.D.A

I would like to remind you that the government considers the consumption of alcohol injurious to health and DSIDC has begun to install CCTV cameras to monitor acts of hooliganism in the vicinity of liquor shops. There have also been several occasions where residents have protested against the opening of liquor vends in the city

We request you to carefully evaluate the ramifications of such a move and only take further action on such vends after inviting opinions from a wide cross section of society. The Resident welfare Associations of Delhi are well represented through the Resident ward committees in each municipal ward and it will be eminently suitable if you enter into consultation with them prior to taking any step in the direction of opening more vends
