

Dear Sir,

This is in reference to Extended Lal Dora land of Village Budhpur, Delhi situated in main G.T. Karnal Road, in Zonal Plan P-1, Narela Zone, wherein as per zonal plan prepared by DDA Lal Dora land of village Budhpur has been taken up for other activities apart from residential as per Master Plan -2021.

Sir for the same we have been giving repeated objections but no satisfactory reply have been given to us, attached are all the copies of the objection that has been filed from us, for the same we had given our objection in open house meet held at the DDA office on 30th April, 2012,

The fact that I would like to bring to your notice that we had been called by the DDA officials for a second house meet held on 21st August, 2012 at the Delhi Central Secretariat where in all the top DDA officials along with the Vice Chairman to DDA and Planning Commissioner Mr. S.P. Bansal was present I had objected to the same matter where in I had received a reply that "I should approach the DELHI JAL BOARD" for the said matter I would like to confirm from the DDA that the said matter is concern to DDA and not to any other organization, DDA must object to this as our land is a Lal Dora land and it is purely meant for Residential purpose and not for any other public utility like S.T.P

On the other hand while preparing the Zonal plan DDA did not kept in mind the already existing population of the village who are already living there from past 30 years on the said land.

As per Gazette below it clearly states that Lal Dora property cannot be used for any other purpose, reference to clause stated below Specific rules for Lal Dora land has been specified In The Gazette of India Extraordinary, Part-II, Section 3, Sub Section (ii), Published by Authority, No 1156, New Delhi, Tuesday, August 12, 2008/SRAVANA, 21, 1930 the use of Lal Dora Land was enacted. On page 21 Sub Clause 8 (2) (VI) under Chapter 17

This Sub- Clause shall be modified to read as under:-

“(V) Land use of village Abadi (Lal Dora/firni) located in any use Zone is Residential.”

Copy of the layout is attached where it clearly shows that DDA has taken up land for Sewerage Treatment Plant.






