This is in reference to Extended Lal Dora land situated in various villages; in the zonal plan that you have prepared it is no where cleared the use of activities that can be done on Lal dora land.

The Zonal Plan that has been prepared by DDA has completely not cleared the use of the Lal Dora land the competent authority is not allowing the land owner to construct houses neither allowing to do any other activity

Therefore my suggestion is to please make it clear the activities that can be carried out on Lal Dora land and therefore suggested to allow following activities on Lal Dora land like **Schools, Colleges and Hospitals, Nursing Homes Etc. sanction of building plan according to building bylaws should be given on Lal Dora land as till now there is no authority who is giving any clarification about sanction of building plan. Group housing should also be allowed on Lal Dora Land**

In the end you are requested that for the benefit of the villagers and common man the rules and regulation should be made very simple and precise so that they do not face any difficulty and illegal things should not be encouraged.
