1. Local Colony gap: Should be made with the consultation of
RWAs of that area,
2. PART OF PLOT :- Should have a Independent Identity for
getting approval of building gap from M.C.D
3. UNUSED NEAR BY DDA LAND :- R & M Blocks Model Town-III
(ward no. 13 Sheepsur) does not have any facility of
Local Hospital, Gymnasium, Recreation Centre for
Senior Citizen, library. your honour is requested to
make a provision of said facility in your master PLAN 2021.
4. UNAUTHORISED ENCROACHMENT :- It should strictly removed
5. PROPER CO-ORDINATION WITH DIGGING AGENCIES :-
There should be specific period for digging of Roads &
Foot path for Execution of New work by MCD, NDPL, BSES
JALBARD IGL and Telephone Department.
6. STREET ROAD CONSTRUCTION :- In developed area the
road level should not be raised to avoid affecting of
house level.
7. Commercial Area of main road of all Colonies should
be increased. on Justification.
8. SCHEDULE MAINTAINANCE :- It is very Important factor
to keep schedule maintenance for Sewer cleaning,
NDPL & BSES (Earthing check of Poles). Community Centres,
water Tanks, heavy Nalas, Parks, DDA Grounds. Etc.
