VILL. PBERA GARH

Respected Sir,

① The consolidation of Land Holdings of the Vill. took place in the year 1953-54. Some agricultural land was allotted to the land holders on the periphery of Lal Dosa of the Village, and its area was bounded by a line (Demarcation) around the vill. called Extended Lal Dosa.

② The details (measurements) of all the lands is available with the Revenue Deptt.

③ So encroachment of lanes/paths can be earmarked and the encroachment can be removed.

④ Land use should be changed to Industrial/Commercial

⑤ Delhi Rent Control Act should not be applicable in Urbanised Villages.

⑥ An expert committee should be set up to frame Building Bye-Laws for the Sanction of Plans.

⑦ Notification dt. 17 Jan, 2011/S.O. 97(E) should be modified

⑧ No Plastic factory for Re-processing of Plastic waste should be allowed.

⑨ To control the Pollution and encroachment on Public Land and un-authorised constructions in the urbanised villages of Delhi, a Panchayat like system should be formed consisting of villagers.

⑩ No house-Tax should be levied on the village as their only means of livelihood has been taken away (Agricultural Land) by the Govt.
