Sir/Madam,

I am a resident of village Pandwala Khurd, New Delhi-43. Sixty(60) years back, consolidation process was carried out in my village and at that time only the residential area was increased too. The situation after that is as follows-

1. The Govt. of delhi felt the requirement of consolidation of the village in 1996 and on 22nd March, 1996 a notification was issued by the revenue department with notification NO. Rev.Estt./1175-80/no.f.22(1)/consolidation/85.
2. Even After 16 years, no action has been taken against the above issued notification.
3. Regarding this problem of extension of Lal-Dora, the villager met C.M. DELHI Smt.SHEELA DIXIT on 19-01-2009 and gave a written presentation with file number 09612493/1589/SDM-HQ - 10/05/2011 / which is pending with DC REVENUE-HQ.
4. The villager also met to the Revenue Minister SH. RAJKUMAR CHAUHAN on 05-02-2009.
5. A meeting was also held with the D.C.South West Revenue regarding consolidation in mid APRIL 2009.
6. Villagers also approached M.P. Sh.MAHABAL MISHRA in last week of April.

OBJECTION

1. The Master Plan-2021 framed by DDA has not given even a look and solution to our village's problem of Lal-Dora that has been prevailing since last 60 years.

2. The Master Plan Committee has also ignored the above laid notification NO. Rev.Estt./1175-80/no.f.22(1)/consolidation/85. which is also related the Lal-dora extension of our village!

3. Since 1952, the village population has increased 8times to 10 times and the village residential area has not been extended since then.

4. Due to the strict vigilance of the police department and as per the constitutional rule, the village people can not construct residential place out side the Lal-Dora on the agriculture land. Due to this, the village people are facing a acute problem for residential land inside the village!

5. The Master Plan should not be finalised without taking our villages's problem of extension of Lal-Dora into consideration.

If the Master Plan is going to be finalised without solving the village's problem, the problem will remain the same forever.
