It is brought to your kind notice that some piece of land bearing Khasra Nos. 42/12, 19, 20, 21, 22/1, 22/2, 47/16, 52/ & 3/2/2 falling in Village Safipur Ranhola in Planning Zone K-I. Total land measuring about 34 Bighas and 16 Biswas i.e. 7.25 Acres was executed in my Company's name as per sale deed (e-stamp) duly registered from the office of Sub-Registrar, Punjabi Bagh, New Delhi.
