Sub: Reference your advertisement in TOI/HT dated 16-05-2012 inviting Suggestions for 'Review of Master Plan for Delhi 2021'.

Dear Sir,

With due regards, I wish to propose the following suggestions in Master Plan Delhi 2021. Though some of them might already be there, but their non-implementation is a serious concern that the planning department needs to concentrate.

1. **Triangular Park-** Since, Apoorva Society is at the intersection of two major roads, there is a triangular park touching one of the boundaries of the society. Due to NO maintenance of the area, this area has become a nuisance where people have started defecating in the open. We would like to request this space to be developed in to a beautiful park and be given to the society for general maintenance which could be used by the public as well.
2. **Service Lane-** At the entry of the society, there is a service lane with a dead end. It has become dumping ground of the debris and garbage. We would like to request you to kindly convert this service lane into a greenway, adding up to the area of triangular park mentioned above which could again be maintained by Apoorva Society, jointly with civic agencies. This would add to the aesthetics of the place.
3. **Covering of nallah-** At the intersection of the road, there is a partially uncovered nallah open to Madhu Vihar drain which has become a bed for mosquitoes and garbage. Kindly arrange to cover this 150 m stretch of the nallah as soon as possible.
4. **Back lane-** There is a back lane that runs entirely from plot- 14 to 18. This is again a dead end. For many years, anti- social elements have been found here creating nuisances and doping themselves. We would like the fence to be raised at the periphery and convert this lane into nice greenway which could be used and maintained by all the 5 societies jointly.
5. **Stormwater carrying nallah-** It is understood that an amount of Rs. 18.5 crore has been sanctioned for the beautification of this nallah with large foliage trees, pedestrian walkways, cycle tracks, parks, etc. The foul smell is a pain in the neck for all the residents of nearby areas and prone to any epidemic outbreak, we would like you to place this project on top priority.
