Subject: Review of Master Plan 2021 – Clause 15.6.3

Dear Sir/Ma'am,

As required for the subject meet, following are our strong suggestions/recommendations:

1. Our premises are on <sup>24 Barjinder kaur</sup> ~~60~~ meter wide main road adjacent to GK1 market.
2. This area is not conducive to inhabitation, but can only be used as commercial premises given that it is adjacent to GK1 market and it is on main road.
3. Shop has existed prior to <sup>7</sup> ~~7~~<sup>nd</sup> February 2007 Master Plan.
4. We request for increasing commercial space from present 20 meters to 50 meters.
5. Make area mixed land use i.e. NOT restrict to only 24 items that are currently allowed.  
This will result in more convenience to the residents of the area.
