Under Clause 15.6.3.

Increasing the size of Small Shops to 50 sq. mtrs. and further notifying of items/activities to be allowed in Small Shops.

Sir,

The concept of Small Shops in MPD 2021 is to cater daily need of people. Small Shops have been allowed to operate in 20 sq. mtrs. size in all category of colonies including A & B category in the respective items listed in para 15.6.3 of MPD 2021.

Small Shop is restricted to run in a size of 20 sq. mtrs. but in todays time, globalisation & competition it is not possible to keep all the variety of products in a Small Shop and therefore not practical to run. It is our humble submission that the size to be increased to 50 sq. mtrs. The pressure on the infrastructure remains the same whether it is a 20 sq. mtr shop or 50 sq. mtr.

Further Small Shops are restricted to operate in the respective 24 categories. We suggest that there should be **NO RESTRICTION** on the category of trade or items/activities in the list of Small Shop i.e. all activities/trades should be allowed to operate **except the Negative List** as per para 15.6.2. as all the items are necessary and cater daily need of the society.

In 20 sq.mtr size shop the customer has to stand out side the shop because there is no space for the customer within the shop as the size is too small to cater the customers which leads to encroachment. Therefore we suggest to increase the size to atleast 50 Sq. Mtrs.

There are main two suggestion which we would like to be incorporated in the Review of Master Plan Delhi 2021.

Sir,

The concept of Small Shops in MPD 2021 is to cater daily need of people. Small Shops have been allowed to operate in 20 sq. mtrs. size in all category of colonies including A & B category in the respective items listed in para 15.6.3 of MPD 2021.

Small Shop is restricted to run in a size of 20 sq. mtrs. but in today's time, globalisation & competition it is not possible to keep all the variety of products in a Small Shop and therefore not practical to run. It is our humble submission that the size to be increased to 50 sq. mtrs. The pressure on the infrastructure remains the same whether it is a 20 sq. mtr shop or 50 sq. mtr.

Further Small Shops are restricted to operate in the respective 24 categories. We suggest that there should be **NO RESTRICTION** on the category of trade or items/activities in the list of Small Shop i.e. all activities/trades should be allowed to operate **except the Negative List** as per para 15.6.2. as all the items are necessary and cater daily need of the society.

In 20 sq.mtr size shop the customer has to stand outside the shop because there is no space for the customer within the shop as the size is too small to cater the customers which leads to encroachment. Therefore we suggest to increase the size to at least 50 Sq. Mtrs.

There are main two suggestions which we would like to be incorporated in the Review of Master Plan Delhi 2021.
