**Suggestions: Regarding HAF Pocket Planning.**

Respected Sir,

### 1. **Background**

In some zonal plans of DDA e.g. in Dwarka, the Mandir/religious plots are earmarked in HAF pockets in some sectors. These Mandir sites are limited to 400 Sqmt only.

Now see the other provisions made in HAF , one Mandir, one Banquet Hall , one CSC, one Dispensary has been earmarked. The HAF pocket is not too big area, where all the facilities can be accommodated without disturbing to each other. See, here, Banquet Hall provision is adjoining dispensary/Hospital and is in front of Mandir which is not logical from any angle.

**Banquet Hall provision near/adjoining to a Hospital/Dispensary can pose problem to any citizen who is in emergency and needs medical help but due to nearby Banquet Hall, a marriage procession crowd, the ill person in emergency can not reach to Hospital/Dispensary to get medical aid in time. Thus this type of Banquet Hall provision poses a threat to the life of a citizen. It is wrong planning and needs modification whereas such facilities are provided.**

**No Banquet Hall shall be earmarked in HAF pocket**

Generally in Marriage & other functions, lacquer & non-veg. food is served, which is contrary religious sentiments particularly in front of Mandir & devotees. It may lead to verbal dispute & clash and disturb the harmony.

Space provided in the Banquet Hall practically will be much lesser than the actual gathering. In addition to this the position will further worsen when there are two or three marriage functions in Banquet Hall are going to be celebrated at a time. Simultaneously the Mandir is organizing religious functions like Janmashtami, Ramleela, Deepawali, Navratras etc. and Polio camps and other seminars are organized by the Dispensary. This situation will lead to a definite clash between the devotees, patients and other people holding the marriage functions.

Generally in marriage functions a DJ system with loud music is installed & just creates a noise at high pitch which disturbs the patients in the dispensary & devotees in the Temple. This will further lead to a clash situation.

## 2. Suggestion:-

where dispensary site or religious MANDIR site are marked or functioning. These earmarked Banquet Hall sites should be used for other synchronized activity purposes in combination to other provisions made in HAF and considering practical difficulties related with each provision these can be considered for i.e. Meditation Hall-cum-Satsang Hall or Lecture Hall or as another Institutional Land use.

Thanking and hoping the suggestion shall be considered as per merits and details given above in public interest.
