At the outset good initiative to have the meaningful interactions with the public so that, presumably their woes will be taken care.

Few of the suggestions, kindly don't take it accusation.

1. Let there be more field surveys by the concerned officials of Planning Dept to feel the pulse and take 1st hand position instead of sitting in the office and just crying over the green sheets. The scheme of calling abuse of law from the public be avoided because Delhi consists of society where people have regard of each other and generally don't come forward to complaint against others.

2. There is a proposal to widen Andheria More Road to Mahipalpur where the land falling on the right (if going from Andheria More) is inhabited by number of hamlets like

Harecharan Bagh etc and the land lying on⁽²⁾ left all belongs to Government. So it is prayed that if the road is to be widened the same may be done from left hand side without uprooting the peaceful and law abiding citizens of Harecharan Bagh.

3. The colonies built on land which have clear ownership like from L&DO though falling in green area have been in existence and coming in unauthorised colonies. kindly approve them particularly Harecharan Bagh so that sword hanging above the heads of residents by JE, AE of MDC/DDA and of Police be minimised and may prove to be a peaceful abode.

4. Mehrauli area is really choked and needs a fresh exit route from Mehrauli to open to Vasant Kunj, Katwaria and let it be only restricted for the domestic vehicles like scooters + car etc without disturbing flow and fauna of Sanjay Van (duly cared by our worthy LG and VC of DDA.

5. Let the poor residents of Mehrauli
