Subject: Review of Master Plan for Delhi 2021 – A Participative approach.

Sir,

Vasant Kunj Enclave (Block 'A' & 'B'), (Kohi Malikpur village/Rangpuri) an unauthorized colony situated in Vasant Kunj and surrounded by resettled Nangal Devat Village, Shanker camp, JJ cluster and Vasant Kunj C-9 is under consideration of Govt NCT Delhi for regularization. This colony is above 25 years old and inhabited with 300 dwelling units and thousands of residents. Unfortunately there is no space /place left or earmarked for public amenities in this colony. Thus at present there is no park, primary school, health care centre, shopping complex, community centre, Barat Ghar etc.

As the Govt. is now considering for review of the Master Plan 2021, we take this opportunity to appeal to you to earmark some land for the aforesaid public amenities in the area. It is noted that there are a few khasaras no. 1496/2, 1495/1, 1490, 1491, 1494, 1467 under Gram sabha of Kohi Malikpur Village just by side and in the vicinity of Vasant Kunj Enclave Block 'A'. As the public amenities are essential requirement and necessity for any residential colony and unfortunately there is no scope for these Public amenities in this colony, we urge your authority/Delhi Development authority to allot/ earmark at least two Khasaras of the aforesaid Gram Sabha Khasaras no. 1496/2, 1495/1, 1490, 1491, 1494, 1467 approx. Area (Acres) for welfare and public amenities like school, park, playground for children, community centre, Bharat Ghar, shopping Complex, health care etc. in the review process of Master Plan, Delhi -2021.

It is also intimated that there is no space for PSP/LSC in and around vicinity of Vasant Kunj Enclave (A & B) and Nangal Devat so we suggest that Khasara no. 1768/1 & 1767 falling on main road at the entrance of these colonies may be considered for the same.

We/Residents Welfare Association (Regd.) Vasant Kunj Enclave would be highly grateful for this act of kindness.
