Publ. Suggestions regarding master plan 2012  
Ref. Publication dated 24.4.2012 in "Navbharat Times"

In this connection my following suggestions  
are given below for the coming master plan 2012

- (1) There should be a <sup>Provision</sup> procedure to pass the building plan of <sup>two</sup> nearby plots jointly. Already constructed <sup>plots</sup> should be regularised.
- (2) There should be a procedure to pass <sup>the</sup> B.P. of single storey flats which have been allotted by D.D.A. or any other agency.
- (3) At least ~~three~~ <sup>one</sup> meter chhajja should be passed in each & every building.
- (4) Perpetual lease deed of some plots have been cancelled on the grounds of its use as commercial property but now it should be restored when the roads have been declared commercial or mixed land use.
- (5) Due to heavy traffic on roads, parking should be built up under the parks which are situated on the main roads.
- (6) There are too much shortage of toilets in Delhi. Neat and clean toilets are required in our Capital.
- (7) Parks and Trees must be maintained properly which have not being done at present.
