Besides being the Regulator as above, we impart the Chartered Accountancy course for the benefit of students, the strength of which is around 10 lakhs.

The activities of the ICAI are ever increasing. The influx of students joining the course is increasing by around 20% every year. In order to cater to the educational needs of the CA students, the ICAI has been looking out for improving its infrastructure. With this intention, the ICAI has participated in the open auction held on 6th December, 2010 for the above plot of land which was given to ICAI at a cost of Rs. 25 Crore. As per the Conveyance Deed dated 03.05.2011, the land use is meant for "commercial" usage. Though the plot size in terms of our requirement, is small, yet we opted for the same because of its location which houses about 2,275 members and approximately 10,000 students. Meanwhile, we have been advised that the concerned authorities are empowered to change the land use in genuine and appropriate cases, based on needs and requirements.
