In addition to the previous application submitted to your above office on the subject cited above on 11-11-2011. The present applicant begs to submit following lines for your kind consideration:-

1. That, the proposed sub- Arterial 45mW Road, Linking Noida Link road to NH-24 not only technically ^{not} feasible because it will be constructed on the debris of :-

1. Nagarijuna Apartments
2. Datta Bhawan
3. New Ashok Nagar Metro Station

But also it is not economically viable.

2. That a substitute Sub- Arterial Road of 30 Mw from DND flyovers to Kalyanpuri is already under use. It can be extended by a 2.3 KM (Approx) long flyover to N.H.-24 obliged.
