2021 AND DDA Zonal Plan 2010 Zone East. Even then illegal Polluted factories and Transport Companies are in Operation. It is very surprising that 790 industrial units in Vishwas Nagar have been allotted industrial Plots under relocation scheme of Govt. of NCT of Delhi. But they are still operating their industrial units in Vishwas Nagar at the same premises. Nrither the Delhi Govt. Nor the MCD wants to take action against these units.

4. 20 Unplanned industrial areas were notified without taking ground reality into consideration in Dec. 2005 as these areas are heavily built up and densely populated areas and no redevelopment work is possible according to the norms prescribed in the notification. So Denotify these areas.
5. Due to above mentioned illegal activities there is always problem of traffic Jam which have made the lives of the residents a hell.

## SUGGESTIONS

1. Implement the orders of the Hon'ble Supreme Court and Hon'ble Delhi High Court mentioned above.
2. Each and every efforts should be made to protect the residential character of the residential /non-conforming areas.
3. Provisions of parks and recreational centres for senior citizens should be taken on priority basis.
4. Encroachment on roads by commercial vehicles on roads must be dealt strictly by the traffic police & MCD.
