Subject:- Application/Suggestions for Review of Master Plan Delhi-2021 and to consider/put up the Sai Nagar, Meethapur Extn., I 'F' - Zone in place of 'O' - Zone or keep out the Meethapur and Jaitpur from 'O'-Zone .

Sir,

With due respect We would like to request and submits before your goodself as under:-

1. That we have already been submitted the request letter for considering the colonies of Meethapur and Jaitpur ward from out of 'O' -Zone alongwith several request letter with this respect, though my diary No. is 341 in the list of the suggestions.

2. That the Colony Sai Nagar Meethapur Extn., Badarpur is very old existed colony and same is in the process of regularization in the Govt. List and the name of the colony in the list of 1639 Colonies of Delhi is mentioned at the Serial. No. 256 and its registration No. 273 and now the name of the Sai Nagar Colony is listed in the Sr. No. 145 in the list of 1018 colonies those are found very eligible to get the regularization certificate as published in Hindi newspaper daily Hindustan dated 12.05.2012 and these colonies are received the NOC from the all relevant and concern departments.
3. That it is also pertinent to mention here that name in the list of Provisional Regularization Certificate Distributed to the applicants of the unauthorized colonies is mentioned at the Serial No. 207 vide registration No. 273.
4. That it is significant to mention here that the Master Plan 2021 and category of colonies prepared by the DELHI DEVELOPMENT AUTHORITY name of our colony and Meethapur Ward has been mentioned in the 'O'- Zone Area which is absolutely wrong without taking any physical survey and without considering the factual position of the colonies , whereas the radius of 'O- Zone' Area is only up to 300 Meters from the both sides of the Yamuna River as per the orders and directions of the Hon'ble High Court of Delhi and our Colony/colonies are very far from the River Yamuna as same is about 6 to 8 Kilometere distance from the Yamuna River, so there is no possibility to consider our colony in the 'O-Zone' category, whereas there are several Multi Storied Govt. Institutions/Buildings and resettlement colonies allotted by the Govt. are situated in the near Yamuna River or in the Bank of the Yamuna River or River Front.


5. That our colony is not situated either in front of River Yamuna nor at the Bank of the River Yamuna or even near to River Yamuna.
6. That it is also important to mention here that after the Yamuna River there are many villages of Delhi and Faridabad Hariyana are situated and located first, for example , Village Madanpur Khadar, Sarita Vihar, Village- Jasola, and many others of Delhi and Village- Basantpur, Ishmailpur, Agwanpur and Sehatpur etc. and thereafter our colony is located and there is no question to consider our colony in the 'O-Zone' and on the contrary our nearby colonies are considered in the 'F-Zone' by the DDA, hence this present request letter to consider our colony in the 'F-Zone' and keep out from the 'O'-Zone.

It is, therefore, most humbly and request fully prayed before your good self that as per the situation and circumstances mentioned herein above the our colony should be treated and considered in the 'F-Zone' in place of the 'O-Zone' in the interest and welfare of the public and lacs of the residents of the colonies.
