Most humbly it is to be submitted that St. Vivekanand Sr. Sec. School is situated on a piece of land in the revenue records of Village Ladpur, Delhi 110081 in Zone "N". This school is recognized by the Directorate of Education, Govt. of N.C.T. Delhi, and is also affiliated to C.B.S.E Delhi.

Sir, a modified development plan of Zone "N" approved by Govt. of India vide letter No. K/12011/23/2009-DDIB dated 8-03-10 under section 9(2) of DD Act, 1957 was seen by us on the DDA website which was authenticated by ZDP of Zone -N(North West Delhi-111) on behalf of Govt. of India vide letter No K-2011/3/Zone N (NW Delhi -111)/2010-DD.IB dated 01.06.10.

After going through the plan it was found that the name of our school i.e. St. Vivekanand Sec. School is not in the list of application of Pre-existing institutions, where as we had applied for regularization under spot zoning to D.D.A.

Sir,

With reference to your application on the subject noted above, I am directed to convey the approval of the Director of Education, Delhi to grant recognition to your school from Class I to X (Without aid) w.e.f. 1.4.93 subject to the fulfilment of the following terms and conditions:


1. That the school shall strictly abide by the provisions of DSEA & R. 73 framed there under as well as the instructions issued from time to time by the Department.
2. That the school shall admit students without any discrimination of caste and creed.
3. That a proper library shall be established and facilities for the reading room shall also be made available to the students as well as the teachers. Books in the ratio of 10 Books per student shall be purchased and made available to the students.
4. That adequate sports material shall be purchased and made available to the students.
5. That the employees of the school will be given pay and allowances and other prescribed benefits as provided for under section 10(i) of the DSEA, 1973 and Rule 125 of D.S.E.R. 1973. The staff should be paid full salary with allowances through cross cheque before 7th of every month.
6. That the school shall not run any unrecognised classes or conduct any other activities within the school premises as per Rule 50 of DSER, 1973 and all the recognised classes shall be run at one place.
7. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately, and the required staff strength must be complete in all respects as per norms.
8. That the school shall submit the returns to the Act Branch of the Dte. of Education as per rule 180 (1) of D.S.E.R. 1973 annually.
9. Fresh Health Certificate from M.C.D. shall be obtained and produced to the E.O. for verification.
10. The Managing Committee shall regulate the functioning of school strictly in accordance with the provisions of DSEA and R. 1973.
11. The Managing Committee of the school shall not increase fee in the future academic sessions without the prior approval of the Director of Education which is a mandatory requirement under sub-section 17(3) of D.S.E.A. 1973.


12. That all the facilities prescribed under rule 50 and 51 DSER, 1973 shall be made available to the students.
13. Proof to the effect that qualified staff has been appointed per R.R.S. be provided for verification by the E.O.
14. That the staff shall be paid all arrears and shall be paid as per the fourth pay commission pay scales, proof shall be given to the E.O. for verification.
15. That the arrangements of for good drinking water shall be made for all the students as well as the staff and sanitary facilities shall also be provided to the students and the staff adequately.
16. The school shall have the medium of instruction as per Rules 6, 7, and 8 of DSER, 1973.
17. Provident fund Register shall be maintained and the cash book completed and shown to the E.O. of the Zone concerned for verification from time to time.
18. That the Management of the school shall create a Reserve Fund equal to minimum three months salary of the staff in the joint name of the Director, of Education and the Manager of the school.
19. That the violation of any instructions/conditions/rules and regulation of the Department shall lead to action, against the school as per section 21 of DSE Act, 1973.
20. That the enrolment in each section shall not exceed the number of students calculated @ 10 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi, in each class. Number of the existing sections should not exceed the number of class rooms of proper size in the school.
21. That Govt. nominees on the Managing Committee will be asked for immediately and all decisions will be taken in accordance with the provisions in the approved scheme of Management by the D.D.E.(Act).
22. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to action against the school as per section 24 of the DSE Act, 1973.
23. That the laboratory shall be constructed and made functional before the start of academic session 1994-95.
24. That the school shall equip the science laboratory as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
25. All the conditions of recognition under section 4 of the Act will continue to be complied with.

With reference to your application dated **15.04.2010** and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for **Senior School Certificate Examination** for a period of **three years w.e.f. 01.04.2011 to 31.03.2014** in the following subjects:-

- (a) **Languages:-** ENGLISH CORE/ELECTIVE, HINDI CORE/ELECTIVE, SANSKRIT CORE/ELECTIVE.
(b) **Elective Subjects:-** BUSINESS STUDIES, ACCOUNTANCY, MATHEMATICS, ECONOMICS, HISTORY, POLITICAL SCIENCE, GEOGRAPHY, PHYSICAL EDUCATION.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:-

1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
2. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
3. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
7. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the Board every year.
8. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-
