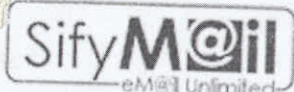

But the land owners are not interested because they have stay at the good areas / places and have strong liaise with Government Bodies.

I would like to know from the MCD top Management, Delhi Development Authorities, Health Ministry and Delhi Government, following questions.

There are no guild lines / law / in our Indian constitutions that no one is authorised to keep plot vacate / without the boundary wall so that people could not dump dirty Garbage. One more very surprise even same place is used by the MCD staff for duping garbage.

There is no law in our legal system where you can send legal notice to the land owners to take necessary action so that General people and MCD staff could stop dumping garbage in residential area.

This plot is vacate since 1947 whereas Delhi Development Authority cannot take in their position and make some children park or their own office there.

I wish to know from all Top management officers.....these land owners are really above the law and our Indian constitutions system.

MCD / DDA/ Delhi Government do not want to take action because of these land owners has strong liaise with top Bureaucrats with MCD, DDA, Delhi Government, and with other Ministry of Parliament. I will not mention the name because I am not concern. But I am concern about my problem which myself is not

ing only, here even more than 500 families also facing this problem since our independence of India from the British Empire.

MCD Management, Delhi Development Authorities, Health Ministry and Delhi Government are really helpless to take action??? Or these authorities are working for these people.

Sirs.... Please do note if (Land Owner-HUF) spend a very little amount of Rs.40000-50000 for boundary of this plot then entire problem could be solved and then no one can throw any kind of garbage.

There is bigger surprise that Land Owner do not allow to the local societies to do the needful like construction of Wall. It shows that how these people are hurting / treating others which clearly show their intention.

They (Land Owners) are leaving at the very good places (Neat & clean areas) and even their earning is so good then still they do not want to take care of this land Wall which shows these land owners deliberately hearting to others since years.

This is really shameful to the all of us that only few people are hearting entire society because of these people have strong liaise with top Government Peoples...if it is not then where is problem with MCD. Delhi/ Delhi Development Authorities/ Delhi Government not to take strong action against these land owners, who are really misusing the Law and hearting the entire society.

It clearly shows our MCD Dept, Health Ministry Dept and Delhi Development Authorities are exclusive working for these people. I am pursing this problem more than 10 years and copying my request to various authorities including The PM House, The Supreme court of India, and The President House.
