Sir,

Respectfully it is informed that Agricultural Produce Market Committee (Market of national Importance) was established during 1976 on transfer from old Subzi Mandi, Delhi.

At that time, the shops were constructed as per sanction plan considering the minimum requirement of the trade.

By the spell of time and requirement on day to day basis, the construction of shops has been gone ahead. As on today there are 4000 commission agents besides other trading activities like hotels, dhabas and other relating trading activities.

This increase in construction was the requirement of the day because the trading activities in the APMC, Azadpur have been increased manifold and considering the present pressure of various trading activities dealing in fruit and vegetables, this increased construction of floors on the existing structure of shops.

While finalizing the review of master plan 2021, it has now become imperative on the authorities to consider all relevant facts while finalizing the said master plan in the public interest rather to take a casual view of the situation putting the commission agents into heavy losses if the FAR of extra floors is not extended up to the constructed limits.
