Sir,

The Hon'ble Chief Minister was a Chief Guest in the function of Seerat-Un-Nabi, held on 28th May 2011 at Dwarka Masjid at HAF, Sector-11, Pocket 'B', Dwarka. Sh. Mahabal Mishra, the Hon'ble M.P. was also present as the Guest of Honour. The function was organized by the Management of Dwarka Masjid. It was attended by huge gathering. In his address, Sh. Sirajuddin Quereshi, President of India Islamic Cultural Centre, Delhi put forward the demand for the allotment of land for EIDGAH in Dwarka Sub-city. It was supported by all the dignatories on the dias, i.e. the Hon'ble Chief Minister, the Hon'ble MP of the area, Sh. Dharam Deo Solanki, Hon'ble MLA of the area, Sh. Mangat Ram, Ex-Minister of Delhi Govt., and the Counsellor of the area.

The demand for the allotment of land for EIDGAH in Dwarka had been persistently made since 2006. We quote the following references in this regard:-

- 1) Sh. Sajjan Kumar, Hon'ble M.P. requested through the D.O. letter dated 28/01/2006 to Sh. Dinesh Rai, the then V.C. DDA for the allotment of land (copy enclosed).
- 2) We requested VC, DDA on 18/12/2007 for the allotment of the land giving the detailed reasoning (copy enclosed).
- 3) In reference to the invitation through the press notice issued by the DDA regarding the Zonal Plan for ZONE-K WEST DELHI, we submitted our suggestion vide our letter dated 22/03/2008, explaining therein the reasoning behind our demand for the allotment of land for EIDGAH. The same is enclosed herewith. Accordingly, the DDA invited us vide DDA letter No. F.4(5)/98/MP/Pt.-III/129 dated 05/08/2008 (Copy enclosed) for the meeting taken by the V.C. DDA on 12/08/2008. The said meeting was attended by Sh. M.A. Haq, Secretary of this Trust. The suggestions were discussed and it was

assured that suitable action shall be taken. We had therefore approached to the Hon'ble Lt. Governor of Delhi vide our letter dated 15/01/2009 quoting outcome of the above meeting with V.C. DDA (Copy enclosed).

- 4) We approached Hon'ble CM vide our letter dated 07/07/2011 (Copy enclosed). The Hon'ble Minister of Health & Family Welfare, Dr. A.K. Walia convened a meeting on 18/08/2011 on the subject which was attended by Dr. K. Srirangan, Dy. Dir. (Plg.), Dwarka Zone, DDA, besides us. The Dy. Dir. (Plg.), Dwarka Zone assured the Hon'ble Minister to suggest suitable sites for the allotment of the land for Eidgah. The office of the Hon'ble Chief Minister, Delhi has endorsed our request to the Land & Building Department (Land Management Branch), Vikas Bhawan, New Delhi who has recommended to the Pr. Secretary, Department of Urban Development for appropriate consideration. The copy of letter dated 25/08/2011 from the Land & Building Department addressed to the Pr. Secretary, Deptt. of Urban Development and letter dated 10/10/2011 from the Department of Urban Development to us is enclosed for your kind ready reference.

Congregational prayers are by huge gathering of Muslim Devotees. Population of the Muslims in the Dwarka subcity is about 10%. The congregational prayers block the traffic on the roads, causing avoidable security risk, besides inconvenience to the devotees and also to passersby.

It is therefore requested to earmark suitable piece of land for Eidgah in Zonal Development Plan for Zone K i.e. for Dwarka (West Delhi).
