This is with reference to the representation of Shahjahanbad Trust, Dwarka regarding allotment of land for Eidgah in Sector-24 near Muslim Kabristan forwarded to the Hon'ble LG, Delhi. The request of Shahjahanbad Trust has been examined from planning point of view and the undersigned is directed to forward the following observations:

- i) In Master Plan of Delhi - 2021, there is no specific mention of Eidgah. However, Community/Multi purpose Grounds are proposed for such social gatherings.
- ii) The area adjoining burial ground in Sector-24, Dwarka is proposed to be developed as Golf Course and the proposal for re-adjustment of land uses in Sector-24, Dwarka, project was approved by the Authority vide Item No.73/2010 in its meeting held on 26.10.2010.
- iii) In view of above, it is not possible to allot land from planning point of view for Eidgah adjoining burial ground in Sector-24
- iv) In Village Dhulsiras, Sector-24, Community Hall cum Function Site measuring 1.05 hect. Has been planned by the Housing & Urban Project Wing (HUPW), DDA and approved by the Screening Committee.
- v) A Community Hall cum Function Site has also been proposed in Sector 7, Dwarka near Palam. The Plans for this have also been prepared by HUPW and approved by the Screening Committee.
- vi) These Community Hall cum Function sites can be used for such social gatherings.



The Dy. Director Planning, Master Plan Section, DDA has given you incorrect and incomplete feedback in respect to our demand on the subject; which was recommended by your goodself to the DDA. Our comments are as under:-

1. Congregational prayers i.e. Eid-UI-Fitra and Eid-UI-Azha are not social gathering as has been mis-communicated by the Dy. Director (Plg.), DDA. They are congregational prayers of Muslims of all ages and from all walk of life and both prayers are FARZ (Obligatory). is not merely a traditional festivity or social gathering. It is enshrined into the religious and personal life of every Muslim. It is not merely a celebration. So, the feedback given by the Dy. Director (Plg.) DDA is not only incorrect and incomplete but it tantamount to misrepresentation of the fact also.
2. These prayer can not be stopped. So, they are held on streets, roads. Thus causing blockage of streets, roads which is not only security hazard but great inconvenience to the devotees and passersby.
3. Congregational prayers of EIDS can not be accommodated in Community Hall as the Muslim population is approximately 10% of total population.
4. EIDGAH can be located anywhere in Dwarka subcity and not necessarily in Sector-24, Dwarka.
5. Suggestions for Mid-Term Review of Master Plan for Delhi-2021 has been invited by the DDA as per the Press Notice dated 04/10/2011 (enclosed).

- ii) The area adjoining burial ground in Sector-24, Dwarka is proposed to be developed as Golf Course and the proposal for re-adjustment of land uses in Sector-24, Dwarka, project was approved by the Authority vide Item No.73/2010 in its meeting held on 26.10.2010.
- iii) In view of above, it is not possible to allot land from planning point of view for Eidgah adjoining burial ground in Sector-24.
- iv) In Village Dhulsiras, Sector-24, Community Hall cum Function Site measuring 1.05 haect. Has been planned by the Housing & Urban Project Wing (HUPW), DDA and approved by the Screening Committee.
- v) A Community Hall cum Function Site has also been proposed in Sector 7, Dwarka near Palam. The Plans for this have also been prepared by HUPW and approved by the Screening Committee.
- vi) These Community Hall cum Function sites can be used for such social gatherings.
