The Dy. Director Planning, Master Plan Section, DDA has given you incorrect and incomplete feedback in respect to our demand on the subject; which was recommended by your goodself to the DDA. Our comments are as under:-

1. Congregational prayers i.e. Eid-ul-Fitra and Eid-ul-Azha are not social gathering as has been mis-communicated by the Dy. Director (Plg.), DDA. They are congregational prayers of Muslims of all ages and from all walk of life and both prayers are FARZ (Obligatory). is not merely a traditional festivity or social gathering. It is enshrined into the religious and personal life of every Muslim. It is not merely a celebration. So, the feedback given by the Dy. Director (Plg.) DDA is not only incorrect and incomplete but it tantamount to misrepresentation of the fact also.
2. These prayer can not be stopped. So, they are held on streets, roads. Thus causing blockage of streets, roads which is not only security hazard but great inconvenience to the devotees and passersby.
3. Congregational prayers of EIDS can not be accommodated in Community Hall as the Muslim population is approximately 10% of total population.
4. EIDGAH can be located anywhere in Dwarka subcity and not necessarily in Sector-24, Dwarka.
5. Suggestions for Mid-Term Review of Master Plan for Delhi-2021 has been invited by the DDA as per the Press Notice dated 04/10/2011 (enclosed).

You are our most beloved elected Hon'ble M.P. of this locality. You have been supporting our genuine and right cause. Our this demand has been persisting for more than five years. Your goodself may therefore, send strong recommendation to the Planning Department of DDA in reference with the invitation sought by the DDA through press notice for mid term review of Master Plan for earmarking suitable piece of land for EIDGAH in Zonal Development Plan for Zone-K i.e. for Dwarka, New Delhi.



- 4) We approached Hon'ble CM vide our letter dated 07/07/2011 (Copy enclosed). The Hon'ble Minister of Health & Family Welfare, Dr. A.K. Walia convened a meeting on 18/08/2011 on the subject which was attended by Dr. K. Srirangan, Dy. Dir. (Plg.), Dwarka Zone, DDA, besides us. The Dy. Dir. (Plg.), Dwarka Zone assured the Hon'ble Minister to suggest suitable sites for the allotment of the land for Eidgah. The office of the Hon'ble Chief Minister, Delhi has endorsed our request to the Land & Building Department (Land Management Branch), Vikas Bhawan, New Delhi who has recommended to the Pr. Secretary, Department of Urban Development for appropriate consideration. The copy of letter dated 25/08/2011 from the Land & Building Department addressed to the Pr. Secretary, Deptt. of Urban Development and letter dated 10/10/2011 from the Department of Urban Development to us is enclosed for your kind ready reference.

Congregational prayers are by huge gathering of Muslim Devotees. Population of the Muslims in the Dwarka subcity is about 10%. The congregational prayers block the traffic on the roads, causing avoidable security risk, besides inconvenience to the devotees and also to passersby.

It is therefore requested to earmark suitable piece of land for Eidgah in Zonal Development Plan for Zone K i.e. for Dwarka (West Delhi).



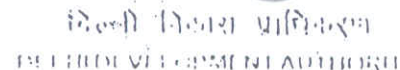
