Proposals to be included in MPD-2021

1. **Vocational Training Institute in Paschim Vihar –** There is no Vocational Training Institute or a Degree college in Paschim Vihar. Candidates have to go to far off places to get these facilities. This involves wastage of time and money. A plot of land near Raksha Kunj has been earmarked for the purpose.
2. **Convention Center –** There is only one Convention Center viz. India Habitat Center in Lodhi Road. Assembly Constituency No.15 badly needs one such Center for organizing exhibitions, seminars, conferences and events connected with promotion of art and culture. A site behind Ordnance Depot is available for the purpose.
3. **Government Hospital in Paschim Vihar –** Paschim Vihar does not have a single public hospital. A private hospital does exist, but it is too costly for the poor and the deprived. Even residents with middle income cannot afford treatment there.
4. **Library –** There is no public or private library in the sprawling colony and in the adjoining areas. The general public especially the students, scholars and writers find it difficult to get books to advance their careers and satisfy their hunger for literature.
5. **Coffee Home –** There is no place where residents can meet and share their woes and views over a cup of coffee. It has been seen that great artists and scholars have benefited from their meetings in such places.

6. Road from Meera Bagh, Paschim Vihar to Ring Road, near ESI Hospital, along Najafgarh Drain will allow hurdle free traffic from both ends of the road. Presently, the roads carry very heavy traffic with frequent blockages. The suggested would provide an alternative route.
7. District Center in Peera Garhi Camp, near Paschim Vihar – There is no District Center within 10 kms and the justification for such a center cannot be over emphasized. A provision for such a center already exists.
8. Cinema in Paschim Vihar – There is no cinema or any other form of entertainment in Paschim Vihar. A site was marked for a multiplex cinema in A-2 Community Center but the site has been allotted to a Mall. A provision may be made for a multiplex cinema site.
9. Underpasses in Paschim Vihar – Presently a large number of kids from Multan Nagar to Paschim Vihar and vice versa. Other residents also come to Paschim Vihar due to lack of facilities in Multan Nagar. In the process they have to cross, Rohtak Road, NH-10, which is very hazardous. An underpass between Multan Nagar and Paschim Vihar is a must.

The T-point in front of Jawala Heri chowk remains choked due to very heavy traffic. An underpass/flyover at this point is the dire need.

10. **Senior Citizen Home in Paschim Vihar –**
There is no place where senior citizens can meet and relax. These days when the senior citizens population is very and is growing, the need for such a center is a must.
11. **Construction of Local Shopping Center, opposite Mitra Vihar, near Vishal Bharati School, Pitam Pura –**
There are a number of flatted complexes around the site, which do not have any local shopping center in the vicinity. A provision for the same may be provided.
