MASTER PLAN OF DELHI- 2021.

Sir,

1. I retired from the Army in Sep 1991 and have been residing in B- 42 Kailash Colony since then. Since May 1992 my wife and I had been running a Salon and Spa in the Lower Ground Floor of B- 42 Kailash Colony on a 15m wide road by the name of Blushes and Blaze. The same was sealed by MCD on 7.9.2007.
2. I understand that MPD 2021 is being revisited by The Ministry of Urban Development. I had observed certain lacunae in MPD 2021 as amended which may be there due to oversight. I am confident that if I had approached The Ministry prior to publication of MPD 2021 and its amendments, the same would have been rectified. Four issues need to be addressed.
3. Amendments to the Master Plan of Delhi 2021 were notified on 12.08.2008. By virtue of amendment No. 16 Salons and Spas came under the category of 'Public and Semi Public Activities'. MPD 2021 and these amendments dated 12.08.2008 permit us to reopen our Salon subject to some other conditions since the cut off date is 7.02.2007. We had been functional since May 1992.

ISSUE-1

4. Amendment No. 19 to MPD 2021 permits coaching centres and tuition centres in all colonies planned and developed prior to 1962 including A and B category Colonies even on a 9m ROW. This makes 1962 an important cut off date.
5. Annexure 1 to Chapter 15 of MPD 2021 gives a List of Pre 1962 Built Up Residential Colonies. The List does not include Kailash Colony. My Late father purchased B-42 Kailash Colony, a 516 sq yds plot from DLF in 1953 i.e 5 ½ yrs after partition since all our landed and residential properties were left in Pakistan. It was Registered in 1957. The List may kindly be amended to include Kailash Colony as a pre 1962 plotted developed Colony.

ISSUE-2.

6. A and B Category colonies are required to have a minimum road width of 18 m for other activities as specified in para 15.7.2. of MPD 2021. Kailash Colony, a Category 'B' Colony is a pre 1962, regular plotted developed colony where the maximum road width on any road inside the colony is 15m only. This implies that other than coaching centres and tuition centres no other public / semi-public activity can be conducted in Kailash Colony even though it may have been functional well before 7/2/2007. This appears discriminatory, specially so, when coaching centres are permitted even on a 9m roadwidth in 'A' and 'B' Category Colonies. A coaching centre is far more noise polluting than a Salon and Spa. I therefore request that this requirement of 18m ROW may kindly be reduced to 15m / 9m ROW for category B colonies. Alternatively, Salons and Spas may kindly be bracketed along with coaching centres and tuition centres in Amendment No.19 to MPD 2021 so that they could also function from a 9m roadwidth.

ISSUE – 3.

7. Amendment No. 25 to MPD 2021 now permits Gymnasiums / Yoga and Meditation Centres to function from all floors including Basements. Salons , Spas and Weight Loss Centres are similar in nature to Gymnasiums and Yoga Centres. In my opinion Gymnasiums and Yoga Centres need a lot of fresh air as compared to Salons and Spas which need a peaceful and quiet environment. I therefore request that Salons and Spas must be bracketed along with Gymnasiums and Yoga Centres in Amendment No. 25 to MPD 2021 so that they could also function from Lower Ground Floors (Basements).
8. It would be pertinent to mention that a large number of other activities including professional activities are permitted in Lower Ground Floors (Basements). A Salon and Spa is non polluting and needs peaceful and quiet surroundings. An air-conditioned Lower Ground Floor (Basement) is ideally suited for a Salon and Spa. The modifications proposed by me of reducing the roadwidth limitation in Category 'B' Colonies from 18m to 15m / 9m and of bracketing Salons and Spas with Gymnasiums / Yoga and Meditation centres in Amendment No.25 to MPD 2021 would give value addition to Salons and Spas functioning from Lower Ground Floors (Basements).

ISSUE – 4.

9. After the sealing of the Lower Ground Floor (Basement) on 07 Sep 2007, we were forced to move to a rented premises. The last rent inclusive of service tax paid by me was Rs. 2.20 Lacs approximately which I could not afford. Therefore, wef 01 April 2011 we had to close down the salon which we had run for 19 years. Because of our professionalism we had built a good brand name for Blushes and Blaze

over a period of 19 years in Kailash Colony and other surrounding areas. After closing the salon we are losing this brand name.

10. I understand that there have been further changes / proposed changes by the Ministry of Urban Development in MPD 2021 during the past 2 months. Establishments which were not sealed, for whatever reasons, earlier, can continue with their business till Dec 2014.
11. I was on the wrong side of law in Sep 2007 and my premises was sealed. As a soldier and a law abiding citizen I took it smilingly in my stride. I probably have only 4 to 5 years of working life left since I am already 68. In case your Honour finds my submissions reasonable and logical, I request you to grant me permission to reopen my salon in the Lower Ground Floor of B-42 Kailash Colony. If by Dec 2014 MPD 2021 as amended does not permit me then I will voluntarily close the salon. I would then be on a Level Playing Field with others who had managed to avoid sealing for some reason or the other. This would also make me financially stable at this stage in life.
12. It would be pertinent to mention that I had filed a case before The Hon'ble Supreme Court on this subject which was admitted on 02.012.2008. I argue in person and have personally appeared before The Hon'ble Supreme Court 5 times since the admission of the case. The Ministry of Urban Development has not filed a reply. The case is now listed on 13th March 2012. My case No. is IA No. 2364 and 2365 of 2008 in IA No. 22 in Writ Petition (C) 4677/1985 'MC Mehta versus Union of India and others.


